# FROM THE CHAIR

I have been reflecting on our Ngāti Apa ki te Rā Tō journey. In particular, since our pou kuia Kath Hemi presented to the Waitangi Tribunal our claim in May 2003. In a 2008 report, the Tribunal upheld all of Ngāti Apa ki te Rā Tō claims, culminating on October 29 2010 with the then Minister Chris Finlayson and Ngāti Apa ki te Rā Tō signing our Deed of Settlement.

It is to this Deed of Settlement that I'd encourage all our members to reflect on. Here is an excerpt from the deed itself.

"The Crown apologises to Ngāti Apa ki te Rā Tō for past dealings that breached the Crown's obligations under the Treaty of Waitangi. These were the failure of the Crown to adequately recognise the customary rights of Ngāti Apa ki te Rā Tō in its resolution of New Zealand Company transactions and its pre-1865 purchases of land, the exclusion of Ngāti Apa ki te Rā Tō from the Nelson and Motueka tenths reserves and the Crown's failure to set aside adequate reserves and to ensure that Ngāti Apa ki te Rā Tō retained sufficient lands for its future needs."

We are faced with a constant barrage from other iwi who purport to know our history, they try to rewrite it, while questioning our place in Whakatū. I envision every Apa mewmber being able to confidently say that we belong in Whakatū.

### **Questions and answers from the AGM**

**Q:** "If we ask a question for something to be discussed at Board level, how do we know the board have had a discussion and how do the Board action what has been asked and how do we get to know the result?"

A: The board are regularly asked questions. Questions often come via email or a phone call to staff. Depending on the query, there may be a quick response by support staff. In other instances, it may be more appropriate for the chair, deputy chair or chair of a sub-Committee to respond. If a question requires more consideration where a vote may be most appropriate, then the take is put on an agenda for full board consideration. The outcome of the full board consideration is then relayed to the member asking the question. Some questions and answers may also appear via the pānui particularly where the impact may be significant to all iwi members. The 'Chair Update' in the pānui is also another avenue by which we convey information that needs to reach our wider membership and the website also has updates that are brought to the wider iwi attention.

**Q: "**Does each sub-Committee have a 'Terms of Reference' (ToR)?"

A: Yes

#### Q: "Why are we asked to complete so many surveys?"

A: The information gathered allows the Board to make informed decisions. Surveys are but one tool used to help the Board shape our 'Strategic Plans'. They are valuable in the sense that a response comes directly from our iwi members. I have mentioned many times the value of evidence-based data as opposed to making assumptions. Extrapolating information/data is only useful if the questions asked are appropriate, therefore, quality is important. The current initiates the board are looking to implement have required substantial member input and I'm happy to advise that the member participation has enabled us to collect valuable data.

#### Q: "Is there an Apa story?"

**A:** There is a Ngāti Apa narrative, treasured as taonga by many whānau. Furthermore, Ngāti Apa ki te Rā Tō commissioned historian David Armstrong to collate accounts and information on behalf of the iwi and this research formed the basis of information put to the Waitangi Tribunal in our claims. More information was gathered during our negotiations. We continue to research and provide our Ngāti Apa ki te Rā Tō stories in pānui and wānanga.

### **Q:** "Are there programmes to train people for General Manager (GM) roles?"

**A:** Yes, there are business courses and university degrees that provide a prospective GM the necessary skills to perform all the duties required in this modern work environment. However, experience in an industry and rising through the ranks is still not unheard of.

### **Falcon release**

On the 10th of January, Ngāti Apa ki te Rā Tō participated in the release of two juvenile female kārearea at a Lake Chalice vineyard in Tyntesfield.

This important kaupapa organised by the Kārearea Falcon Trust was also attended by Ngāti Kuia and the Department of Conservation.

The kārearea chicks were put in a nest box before they could fly, so when they came out of the box during the release, we got to see their first flight! They were naturals. One took off immediately, while the other perched on the ledge for about half an hour (pictured above) before flying to a nearby tree. We have had an update on their progress and they are both still doing well. Ka mau te wehi!
